

Hot Tub Risk Acknowledgement and Disclaimer

This is an important document: You must READ IT BEFORE SIGNING

I acknowledge that I am signing this acknowledgment and disclaimer on behalf of each member of my party and will ensure that each member of my party is aware of, and strictly adheres to, the guidelines set out below when using the hot tub ("Hot Tub").

I and all members of my party hereby agree to ensure that any children in my care, or associated with my party, are properly supervised at all times when they are in the vicinity of the Hot Tub. Extreme caution must be taken to ensure that no child under five years of age is permitted to enter the Hot Tub at any time and that any children over five years of age and under 16 years of age using the Hot Tub are closely supervised and monitored at all times.

I and all members of my party understand and agree that:

• The use of drugs, alcohol and some medications before or during use of the Hot Tub may lead to unconsciousness with the possibility of drowning, and can greatly increase the risk of fatal hyperthermia.

• Glass items are not permitted in the Hot Tub.

- No member of my party may use the Hot Tub without prior consultation with a doctor if he/she is obese or has a medical history of heart disease, low or high blood pressure, circulatory system prob lems or diabetes.
- Some medications may induce drowsiness and others may affect heart rate, blood pressure and circulation. If any member of my party has recently taken or is currently taking any medication, he/she will consult a doctor before using the Hot Tub.
- No member of my party may use the Hot Tub if he/she has an infectious disease or has any open sores and/or wounds because of the possibility of spreading infection.
- No member of my party may use the Hot Tub if she is pregnant or potentially pregnant without prior consultation with a doctor.
- Prolonged immersion in the Hot Tub may be hazardous to health.
- The Hot Tub must not be used immediately after strenuous exercise.
- Electric appliances (such as lights, telephones, radios or televisions) are not permitted within five feet (1.52m) of the Hot Tub.
- Suction guard(s) must not be removed from the Hot Tub. The Hot Tub shall not be used unless all suction guard(s) are installed to prevent body and hair entrapment.
- The Hot Tub will be kept covered at all times when it is not in use.
- All members of my party will shower both before and after using the Hot Tub.

I and all members of my party accept and acknowledge that risks and injury may be caused or increased by our own acts, omission, negligence or failure to follow any guidelines provided to us and Merlin shall not be liable in such circumstances. We also accept and acknowledge that we will be held responsible and incur charges for any damage to the Hot Tub which occurs during our stay.

Merlin accepts no responsibility for any direct or indirect loss, damage or injury suffered or incurred by any person using the Hot Tub, other than in relation to death or personal injury caused by Merlin's negligence.
